



# AFTER SCHOOL 2011-2012

## Rabun County School System

**Rabun County Community of Learners (RCCL)** after school program is federally funded through the Georgia Department of Education's 21<sup>st</sup> Century Community of Learning Centers.

**The purpose** of the after school program is to provide expanded academic enrichment opportunities for children through tutorial services, enrichment activities, technology education, recreation, and character education. The program specifically targets students who perform at Level One on the Criterion Reference Competency Test (CRCT) for students in grades 1-8 but is available to all students who choose to attend.

**The after school program operates Monday-Friday each week from 3:15-5:40 p.m. The After School program will begin September 6, 2011. The following information is important for parents and students who attend after school:**

1. **Student success is a top priority.** In order to maximize student learning, all students are expected to conduct themselves in a manner that promotes a positive learning environment. Good behavior is essential. Students who interrupt the learning environment will be removed from the program.
2. **Transportation is provided to students who wish to use the drop off sites for reaching home. Students must abide by the same bus safety rules as the regular school day. Parents must be at the designated drop off site on time in order for students to continue to ride the bus.**
3. **Parents are welcome to pick students up at each school by 6:00 p. m.**
4. In order for students to get the maximum benefit of the program, **they are required to attend at least three of the five days each week. Students who do not will be dropped from the roll and parents will need to reapply before students can attend.**
5. Medication taken by students during after school hours must be delivered by parents in the original bottle before it can be administered. **Please notify after school directors of any serious allergies or special needs for students.**
